Provision of a Debit Card. (International immediate debit card).	FREE for the first card per account; mailed free upon request once account balance reaches €500. Cost for Additional Cards (up to 5 cards per account) €10 each (including delivery).
Annual Card Fee.	FREE For the first card associated with the account, provided that one or more payments totaling at least €500 are made during the current month to maintain the free status. Fee for each additional card (up to 5 cards per account): €2 per month.
Card Payments (The card is issued by the bank).	FREE
Cash Withdrawa. (For withdrawals in euros within the Eurozone at another bank's ATM using an international payment card).	FREE Within the limit of 4 withdrawals per month and/or €1,000 in total monthly withdrawals. Beyond this limit, 1% of the additional withdrawal amount. or the amount exceeding €1,000.

Estate Processing Fee	€100 and for accounts with balances over €2,000, 5% of the amount beyond €2,000.
